## 12. ECOLOGICAL INFORMATION

### 12.1 Toxicity

Product is classified as nontoxic to aquatic organisms. However, large spill into natural water systems is expected to cause acute short term toxicity to aquatic life due to depletion of dissolved oxygen levels in the water. Once sufficient natural dilution has occurred no long term effects are expected. The main organic component will tend to bind soil particles together, and will naturally decompose over time (Lignosulphonate is used commercially as soil binders for dirt roads). The residual chemical content will not cause toxic contamination of ground water.

### 12.2 Persistence and degradability

This product is inherently biodegradable.

### 12.3 Bioaccumulative potential

No information provided.

### 12.4 Mobility in soil

No information provided.

### 12.5 Other adverse effects

This product is not anticipated to cause adverse effects to animal or plant life if released to the environment in small quantities. Not expected to bioaccumulate.

**Waste disposal** Solutions: Cover with sodium carbonate (soda ash), lime or similar alkali to ensure pH greater than 8.5. Collect precipitated solids in sealable containers and label accordingly. Solids: Dampen if necessary and avoid dust generation. Collect solids and store in sealable labelled containers. Absorb with soil and contact the manufacturer for disposal instructions.
